INTRODUCTION

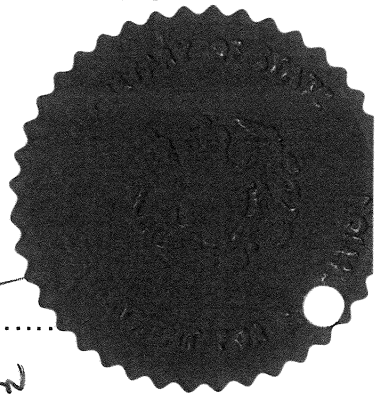
LEGAL AGREEMENT

Schedule 1

Amendments to the Funding Agreement

1. The following clause 59A shall be inserted after Clause 59 of the Funding Agreement:

“59A) Grants paid by the Secretary of State may not be used for the purposes of the Parks and Walcot East Children’s Centre without the prior written consent of the Secretary of State.”
